Making a nomination (To be filled up by member)	<ul> <li>Nomination form, and</li> <li>A copy front and back of Identification Card (MyRad/Police Identification Card / Military Identification Card / Permanent Resident Identification Card (MyPR)) of the member. Copy of the ID should be the front and back.</li> <li>Form must be witnessed by an individual. Witness criteria are as follows:         <ul> <li>Malaysian;</li> <li>Above 18 years old;</li> <li>Of sound mind; and</li> <li>Witness cannot be a nominee, a PRS consultant, an officer of PPA or a PRS Provider or a spouse of the nominee.</li> </ul> </li> <li>During the submission the PRS consultant/ PRS Provider/PPA will verify the identity of the member by checking the original Identification Card (MyKad/Police Identification Card/Military Identification Card)/ Permanent Resident Identification card (MyPR)/ Passport (for foreigner).</li> </ul>
Withdrawal upon death of a member (To be filled up by nominee or applicant [in the case of nominee who has PTD, Serious Disease or Mental Disability, where applicable])	<ul> <li>Withdrawal Upon Death of a Member Form;</li> <li>A copy of member's death certificate*; and</li> <li>A copy front and back of nominee(s) Identification Card (MyKad/Police Identification Card/Military Identification Card)/ Passport (for foreigner).</li> </ul>

	<ul> <li>For Guardian or person appointed by the court (where applicable) who wants to withdraw on behalf of nominee who is below the age of 18         <ul> <li>Birth certificate (as proof of parentage) or a Court order (as proof of legal guardianship)*</li> </ul> </li> <li>For Persons appointed by the court via court order who wants to withdraw on behalf of nominee who is certified as having permanent total disablement or mental disability by a medical practitioner registered under the Medical Act 1971 [Act 50]:         <ul> <li>Court order evidencing proof that such persons are responsible for managing the personal and financial affairs of the nominee and that PRS is part of the scope of assets covered*; and</li> <li>Medical report on a patient/nominee withdrawing from PRS for PTD or Mental Disability (MD) completed by the treating doctor *</li> </ul> </li> <li>For Persons appointed by the nominee via power of attorney who wants to withdraw on behalf of nominee</li> </ul>
	<ul> <li>For Persons appointed by the nominee via power of attorney who wants to withdraw on benan of nominee who is certified as having permanent total disablement or serious disease by a medical practitioner registered under the Medical Act 1971 [Act 50]:         <ul> <li>Power of attorney document evidencing proof of appointment of such persons and that the scope of powers given to the person includes PRS as part of the assets covered*; and</li> <li>Medical report on a patient/nominee withdrawing from PRS for PTD or Serious Disease (SD) completed by the treating doctor *</li> </ul> </li> </ul>
	During the submission the PRS consultant/Provider will verify the identity of the nominee/applicant by checking the original Identification Card (MyKad/Police Identification Card/Military Identification Card)/ Permanent Resident Identification card (MyPR)/ Passport (for foreigner).
	Documents marked with an asterix (*) must be submitted as certified true copies and verified by a Commissioner of Oaths, complete with the name, address and official stamp of the Commissioner of Oaths.

Nomination details enquiry form (To be filled up by Member's next of kin / executor)	<ul> <li>Nomination Details Enquiry Form;</li> <li>A copy of member's death certificate*;</li> <li>A copy front and back of enquirer's Identification card/ Passport; and</li> <li>A copy of relevant document to prove identity of the next of kin (marriage certificate/birth certificate) OR a copy of document as proof he/she is the executor*</li> <li>During the submission the PRS consultant/Provider/PPA will verify the identity of the nominee/applicant by checking the original Identification Card (MyKad/Police Identification Card/Military Identification Card)/ Permanent Resident Identification card (MyPR)/ Passport (for foreigner).</li> <li>Documents marked with an asterix (*) must be submitted as certified true copies and verified by a Commissioner of Oaths, complete with the name, address and official stamp of the Commissioner of Oaths.</li> </ul>
